

Minutes of the meeting of the IQAC held on 23.12.2022 at 12.15 pm in the Board Room, GRI to discuss about the 4th Cycle of NAAC accreditation

The meeting of the internal members of the IQAC began with a silent prayer. The Director, IQAC, GRI welcomed the members of the IQAC. She briefed about the stand of NAAC (Ref.NAAC's notification F.No.14-29/2022 dt.10.11.2022) inviting the institutions to be accredited to complete the Institutional Information for Quality Assessment (IIQA) registration on or before 31.12.2022. As the validity of 3rd Cycle of accreditation ceases on 15.09.2021, GRI has to submit itself for the 4th Cycle. In the meeting, the recommendations of the Academic Audit held on 30.05.2022 and 31.05.2022 were discussed in detail.

On IIQA registration, the institute has to submit the SSR within 45 days, failing which 2 extensions for a period of 15 days may be sanctioned. As per the revised regulations of NAAC, the accreditation process is data intensive, calling for collation of a large volume of data and collation of supporting documents.

At this juncture, GRI may require at least three months to prepare its Self Study Report (SSR). There are certain requirements of NAAC that are yet to be met, such as,

- Availability of a full-fledged Learning Management System (LMS)
- Automation of administrative practice
- Deployment of e-governance
- Addition and augmentation of infrastructure

- Projects and publications of faculty members
- Placement and students' progression
- Outcome assured extension activities

The committee felt that, though the registration of IIQA is the need of the hour, the preparation of the SSR may require a minimum of three months. GRI may need to re-register for IIQA, if the registration ceases.

The committee also felt that non-registration of the IIQA on or before 31.12.2022 may invite the disadvantages to GRI as the institute may become ineligible to submit proposals for funded projects and other accreditations.

Moreover, non-registration of IIQA may handicap GRI's participation in Ranking and Accreditation wherein the NAAC's accreditation is deemed to be mandatory.

In view of the above, the members of the committee suggested that the IQAC should follow the directions of the authorities either register or not register for IIQA, for its 4th Cycle of accreditation, on or before 31.12.2022.

The committee also suggested that the authorities may convene meetings of the Deans / HoDs / Directors exclusively to deliberate on the suggestions of the Academic Audit and discuss the elements of NIRF and ARIIA to improve GRI's rankings.


The meeting came to an end with a vote of thanks by the Director, IQAC, GRI.
